**ORDER**

As per Government Order read as 1<sup>st</sup> paper above, Government accorded sanction for the creation of 8 posts in State Level Nodal Agency (SLNA) and 3 posts in Watershed Cell cum Data Centre (WCDC) of three districts subject to the conditions specified therein. Further it was extended to all districts vide Government Order read as 2<sup>nd</sup> paper above. As per Government Order read as 3<sup>rd</sup> paper above, Government have reconstituted the Interview Board with Secretary, Local Self Government Department as Chairman and the Commissioner for Rural Development as the Convenor and 3 other officials as members for the selection of eligible candidates for appointment to the above said posts.

Appointments were already made for the post of Technical Experts (Agri), Administrative Officer & Accounts Assistant in SLNA & one Accountant in WCDC, Palakkad vide Government Order read as 4<sup>th</sup> paper above. Notification has been issued for the appointment of remaining posts in SLNA & WCDCs and interview was held on 15/02/2013 at Commissionerate of Rural Development, Thiruvananthapuram. As per letter read as 5<sup>th</sup> paper above, the Commissioner for Rural Development has furnished the selection list of officers to be appointed to the posts in the SLNA & WCDC and requested to approve the selection list and issue necessary orders.
