As per the letter read as 1st paper above, Government of India have released the 2nd installment of Central Share in respect of PMKSY (WDC) amounting to Rs.5.78 Crore for implementation of IWMP projects under Watershed Development Component of PMKSY in the State of Kerala during 2017-18. As the funding pattern of the scheme is 60:40, the 40% share of the fund has to be borne by the State Government. Accordingly, the State Share amount comes to Rs. 3.853 Crore. The Commissioner for Rural Development, as per letter read as 2nd paper above has requested to release the aforesaid Central and State Share of PMKSY(WDC) for the implementation of the project.
