

The decision taken at the review meeting of IWMP /PMKSY held by Dr.V.K.Baby, Special Secretary, LSGD with IWMP (SLNA) team on 04-04-2017 at the chamber of Special Secretary, LSGD at 3 PM.

The Special Secretary has observed that commendable efforts have gone into the preparation of IWMP plans for various projects. However, in the context of the dwindling financial support from GoI as against the projected requirements, every efforts shall be made to see that the plans prepared shall be implemented through convergence. The real challenge for SLNA is to make this convergence happen and see that, the plans are effectively implemented. The SLNA has also to utilize the district, block and LSGI level mechanism to make it happen. Further, following decisions were also taken

- To upload all DPRs in the web site in one week.
- In the web site of SLNA a dash board to be provided to view the progress of the program, both financial and physical and highlight good initiative and replicable models.
- Provisional UC to be submitted to GoI for obtaining 1<sup>st</sup> instalment for 2017-18 in 3 days. Also finalise the audit urgently and submit audited details to GoI. IWMP should be integrated with Harithakeralam and the possibility of accessing fund from MGNREGA should be sought. An approach paper may be prepared by the SLNA team in the broad context of the sharp fall in GoI support as against the projected requirements.
- A costing table to be prepared taking in to consideration of Budget-Central/State/other resources for the watershed plans prepared, taking into consideration the convergence components.
- A clear and well defined strategy to be evolved for completing the ongoing projects on setting priority.

- To make a performance assessment of the Technical staff, a review format is to be developed based on the task and achievement and assess everyone's performance monthly.
- To carry out an asset mapping in the watershed area covering all investments both private and public, within the watershed. Possibility of duplication should also be verified. The plans are to be reviewed once in an year to make contextual changes, that are critical.
- Livelihood activities should be linked with watershed development in a mutually reinforcing linkage.
- To prepare a job profile in the watershed area analyzing the gap from existing job profile and ensuing demands.
- A bucket of options to be worked out at the district level for Well recharging. The menu of cost effective and sustainable location specific technology options be made available and uploaded in the site.
- A Video Conference is scheduled on 10<sup>th</sup> to review the status of projects in the districts.
- A field visit is scheduled on 11-04-2017 at Vamanapuram watershed area.
- Mission water conservation initiatives already piloted at Chittoor in Palakkad District is to be visited on 06-05-2017.
- Steps may be taken to activate the User Groups to improve ownership and maintenance of assets created and interventions made
- A separate working instruction need to be formulated for the utilization of WDF (Watershed Development Fund)
- The possibility of accessing technical support at SLNA level, on call on basis need be examined and a panel of experts prepared.
- Since the flow of resources is rather restricted, prioritization of projects completed, on-going, not-taken up etc need be done. For not started projects the possibility of integration with other departments may be thought off.
- Convene SLNA Urgently
