#### ORDER

Government of India have sanctioned the 1 st Installment of Central Share amounting to ₹13.06 Crore for implementation of projects under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY) during the year 2018-19 in the State. As the funding pattern is 60:40, the corresponding State Share amount will comes to ₹8.7067 Crore. In the State Budget an amount of ₹21.00 Crore is provided in respect of Central Share and ₹14.00 Crore in respect of State Share for PMKSY -WDC program during the current financial year. Hence the Commissioner for Rural Development as per letter read above has requested to release the aforesaid Central and State Share amount urgently, for the implementation of the projects.

2. Government have examined the matter in detail and are pleased to accord sanction for releasing the I<sup>st</sup> installment of General, SCP & TSP components of Central and State Shares of Watershed Development Component of PMKSY from the Budget provision available under the respective heads for the year 2018-19, as detailed below.
