Government of India vide letter read 2<sup>nd</sup> cited above had released an amount of Rs. 5,00,00,000/- (Rupees Five Crores Only) being the 1<sup>st</sup> instalment of Central Share for the implementation of Integrated Watershed Management Programme (IWMP) under Pradhan Manthri Krishi Sinchayee Yojana (PMKSY) : Other Interventions for water conservation and water harvesting works during the year 2015-2016 as Central Share.

The State Government as per Government Order cited 2<sup>nd</sup> have released Rs. 4.46 Crore (Rupees Four Crore Forty Six Lakhs Only) under the General Sector, being 1<sup>st</sup> instalment of Central Share to State Level Nodal Agency being the Central Share for Pradhan Manthri Krishi Sinchayee Yojana (PMKSY) 2015-16.
