Government of India vide letter read 1st cited above had released an amount of Rs. 11,37,00,000/- (Rupees Eleven Crores and Thirty Seven Lakhs Only) being the 1st instalment of Central Share during the year 2016-17 for the implementation of Integrated Watershed Management Programme (IWMP) under Watershed Component of Pradhan Manthri Krishi Sinchayee Yojana (PMKSY).

The State Government as per Government Order cited 2nd have released Rs. 16,88,33,333/- (Rupees Sixteen Crore Eighty Eight Lakh Thirty Three Thousand Three Hundred and Thirty Three only) under General Sector, being 1st installment of Central Share with State share (Rs. 10,13,00,000/- Central Share and Rs. 6,75,33,333/- State Share) to State Level Nodal Agency for implementation of projects under Pradhan Manthri Krishi Sinchayee Yojana (PMKSY) during 2016-17. Out of this an amount of Rs. 16.87 Crore had already been released to the WCDCs.

As per Government Order 3rd cited above, the Government have released Rs. 2,06,67,000/- (Rupees Two Crore Six Lakh and Sixtyseven Thousand Only) being 1st installment of Central & State Share (SCP and STP) for the implementation of Integrated Watershed Management Programme (IWMP) under Pradhan Manthri Krishi Sinchayee Yojana (PMKSY) Watershed Component during the year 2016-17.

The Project Directors, Poverty Alleviation Units, are requesting additional funds for the implementation of Projects. In the circumstances, sanction is hereby accorded to release an amount of Rs. 2,00,00,000/- (Rupees Two Crore Only) to WDCs for the implementation of PMKSY (Watershed Component) projects as given below.
