Government of India vide letter read 1st cited above had informed that an amount of Rs. 5,00,00,000/- (Rupees Five Crores Only) had been released, being the 1st installment of Central Share for the implementation of Integrated Watershed Management Programme (IWMP) under Pradhan Manthri Krishi Sinchayee Yojana (PMKSY): Other Interventions for water conservation and water harvesting works during the year 2015-2016 as Central Share.

The State Government as per Government Order cited 2nd have released Rs. 4.46 Crore (Rupees Four Crore Forty Six Lakhs Only) under the General Sector, being 1st instalment of Central Share to State Level Nodal Agency being the Central Share for Pradhan Manthri Krishi Sinchayee Yojana (PMKSY) 2015-16.

As per G.O (Rt). No.1047/2016/AD dated 16/12/2016, the state Government have released Rs. 3,87,33,333/- (Rupees Three Crore Eighty seven Lakh Thirty three Thousand Three Hundred and Thirty three only) being the State Share under General category and the balance amount of first installment of Central and State Shares under SCP & TSP components for water conservation and water harvesting works during 2015-16.

Now the Project Directors, PAUs are requesting additional funds for the implementation of projects. In the circumstances, sanction is hereby accorded to release Rs. 3,67,20,000/- (Rupees Three Crores Sixty Seven Lakh and Twenty Thousand Only) to the WCDCs as given below:

The Project Directors, Poverty Alleviation Unit, Thiruvananthapuram, Kollam, Pathanamthitta, Alappuzha, Kottayam, Idukki, Ernakulam, Thrissur, Palakkad, Malappuram, Kasargod are directed to deposit the amount to the Bank accounts opened for the purpose and to release the amount to the PIAs according to their requirement and also observing the operational guidelines issued by Government of India and SLNA. The amount may be utilized exclusively for implementation of water conservation & water harvesting activities under NRM and furnish utilization certificate for subsequent release.

The Project Directors and the PIAs are directed to open a separate bank account in any of the Nationalized Banks for PMKSY: Other Interventions, and to maintain separate books of accounts. The Scheme should be audited Separately and exclusive UC should be submitted.

Implementing agency should identify SC/ST beneficiaries among the total beneficiaries to achieve prescribed targets and book the amount of the grant in-aid released for SCs/STs under the relevant Head of Accounts. Implementing Agency should invariably report the same on monthly basis.
