
Sir / Madam,

I am directed to refer to States / UTs requests for extension of project period of Batch IV and Batch-V projects beyond March, 2021 and to inform that the competent authority has approved the extension of project period of **Batch-IV and Batch-V projects** under WDC-PMKSY for **6 (Six) months i.e. (from 01.04.2021 to 30.09.2021)** for qualitative and successful completion of projects. **No release of Central funds for Batch-IV & Batch-V projects during FY 2021-22 is entertained.** States / UTs are permitted to utilize funds already released and lying unspent with them for completion of Batch-IV and Batch-V projects.

States / UTs should ensure completion of all the Batch-IV & Batch-V projects within extended project implementation period i.e. upto 30.09.2021 and also ensure submission of project Completion and End-line Evaluation Reports at the earliest. States/UTs are requested to plan their activities accordingly.
